

# Come Closer: What is ALSA?

The **ASEAN** Law Students' Association (ALSA) officially was established on the 18th of May, 1989, by a collective of law students hailing from Indonesia, Malaysia, Singapore, Thailand, and the Philippines. The foundational accord of ALSA was formalized in Jakarta during the ALSA Conference held in 1989. transformative developments during that period were deemed critical, given that the organization assumed a significant role in harmonizing diverse legal backgrounds across various countries.

This accord stipulated consolidation of ALSA into a singular association, a decision ratified by unanimous resolution by entities, including the ASEAN Law Students' Association, the East Asian Students' Association, the International Department of Legal Aid Association of Peking University, LA HKUSU, ALSA Japan, ALSA Korea, and ALSA Taiwan. This consolidation transpired under а new Asian nomenclature, the Law Students' Association, still referenced by its abbreviation, ALSA.



This endeavor was guided by the vision and mission akin to those of the European Law Students' Association in 2002.

Subsequently, following the Korea Conference and the Asian Forum convened in Japan, ALSA expanded its substantial influence by entering into the Tokyo Agreement on the 7th of September, 2002.

In contemporary times, ALSA is widely recognized as nongovernmental and apolitical organization. Its membership encompasses over 16 national including chapters, those of Indonesia, Singapore, Brunei Darussalam, the Philippines, Macau, Laos, Thailand, South Korea, Vietnam, China, Hong Kong, Sri Lanka, Taiwan, Myanmar, and India.



# **Our Home: About ALSA LC** Unud

The Asian Law Students' Association Local Chapter of Universitas Udayana (ALSA LC Unud) was officially established as the 13th Local Chapter of ALSA Indonesia on the 13th of March, 2012, during the 19th National Congress (Munas XIX) of ALSA NC Indonesia held in Kaliurang, Yogyakarta. The inception of ALSA LC Unud can be traced back to the pivotal roles played by two distinguished figures in our history, namely Nyoman Wicaksana Wirajati (Founder) and Keshia Sifra, who served as the President of ALSA Indonesia from 2010 to 2011.



The initiation of ALSA LC Unud was marked by Universitas Udayana's participation in the National Moot Court Competition (NMCC) Supreme Court Trophy Purwokerto Cup and its co-hosting of an International Seminar and Study Trip organized by ALSA in 2010. Shortly thereafter, we were invited as Observers to events such as the 18th National Congress (Munas XVIII) in Aceh, the 18th National Seminar (Semnas XVIII) in Surabaya, and the 17th Pre-National Congress (Pramunas XVII) in Malang. Additionally, we successfully collaborated on the Study Trip and Diplomatic Course (STDC) organized by ALSA-ISAFIS. Following our official recognition as a Local Chapter during the 19th National Congress in Kaliurang, Yogyakarta, I Gede Bagus Ananda Pratama was appointed as the first Director of ALSA LC Unud during the 1st Local Chapter Meeting (Muslok I) of ALSA LC Unud in Denpasar, Bali.





# ALSA International's Events



## **ALSA Forum (AF)**

The ALSA Forum serves as the highest assembly within ALSA International, convened regularly every mid-year. The primary aim of this event is to facilitate the process of regeneration, presentation of Executive Summaries, and the election new President the of International (International Board) who will assume office in the subsequent term. Additionally, the ALSA encompasses other objectives, including fostering interactions between members and alumni, facilitating legal discussions among members from diverse countries, and promoting cultural exchange.









# **ALSA Conference (AC)**

The ALSA Conference is an annual event conducted by ALSA International Board, occurring during the midpoint of ALSA International's executive term. It serves dual primary objectives. Firstly, the ALSA Conference entails a meeting between the International Board and the National Boards from every National Chapter. Secondly, the ALSA Conference centers on academic endeavors, comprehensively legal issues examining and concerns presently faced, particularly within the Asian continent. This is achieved through Table Discussions and/or Model United Nations sessions, involving all attending delegation members.



## **ALSA International Moot Court Competition (AIMCC)**

ALSA International Moot Court Competition (AIMCC) is an international simulated court competition focused on international resolving investment disputes through arbitration proceedings. Participants of the competition are law students from various countries. The competition involves the submission of memorials for fictitious cases crafted by legal professionals and culminates with pleadings during the duration of AIMCC.







# **ALSA International** Mediation **Competition (AIMC)**

ALSA International Mediation Competition (AIMC) is an international mediation competition designed to train and enhance the knowledge and skills of participants from diverse countries in the realm of Alternative Dispute Resolution. This competition aims to foster the development of participants' capabilities in resolving disputes through mediation.

ALSA International Legal Training and Workshop (AILTW) aims to enhance the practical and technical legal skills of ALSA members. # Seminar dan **Musyawarah Nasional** (Semunas)

The National Assembly is the preeminent organ of the ALSA National Chapter Indonesia. It convenes to address diverse topics, including the assessment of the Accountability Report delivered by the serving National presently Board. Furthermore, the agenda includes pivotal discussions regarding the ALSA Indonesia Articles of Association and Regulations, designation of the upcoming President of **ALSA** Indonesia, of allocation national events, comprehensive review of the NMCC ALSA Court Cup competition array of other guidelines, and an significant matters.









## **Rapat Pimpinan** Nasional (Rapimnas)

The National Governing Council Meeting is the initial national event convened at the outset of the executive term. Typically organized shortly after the election of a new President, this event takes place at the originating Local Chapter of the newly elected President. The discussions during this event encompass the formulation of the National Board's work program, the presentation of prospective candidates for International ALSA positions, solicitation of bids for national events, progress reports from each Local Chapter and the National Board, as well as other agreed-upon agenda items.



## Seminar dan Workshop Nasional (Semworknas)



The National Seminar and Workshop (Semworknas) is an event designed for the examination of legal matters. As implied by its nomenclature, this event is composed of both a seminar and a workshop component. In the National Seminar, a thematic focus is adopted, highlighting legal issues that are pivotal, deemed essential, and engaging for deliberation. Additionally, the workshop constitutes a session wherein participants engage in discussions and practical scenarios to apply legal principles derived from the overarching theme presented during the seminar. Typically, these discussions lead to the presentation of outcomes derived from the workshop exercises.

### **Pra-Musyawarah Nasional & ALSA Leadership Training (PALT)**



The Pre-National Assembly (PRA-MUSYAWARAH) functions as a forum for discussions, the conclusions of which will be followed up at the National Assembly (SEMUNAS). During this event, the mid-year Accountability Report will be presented by the National Board. Participation in this event is limited to three representatives from each Local Chapter. The ALSA Leadership Training (ALT) program aims to cultivate leadership qualities among ALSA Indonesia members, aiming to produce capable individuals who grasp the core principles of possessing an exemplary leadership spirit.



# **National Moot Court Competition** ALSA Piala Mahkamah Agung (NMCC MA)





The National Moot Court Competition organized by the Asian Law Students' Association (ALSA) National Chapter Indonesia, known as the Supreme Court Trophy, stands as one of ALSA Indonesia's flagship national events. This competition represents the oldest simulated court competition in Indonesia. It draws participation from law students across various universities in Indonesia, competing for the prestigious Supreme Court Trophy.
